Gambling addiction and Public Health

Once regarded as a fun, leisure activity, gambling is increasingly recognised as a Public Health issue of some concern. In September 2021, Public Health England produced the first evidence review of the harmful nature of gambling.

In January of this year, the Office for Health Improvement & Disparities produced an evidence update on the economic and social cost of such harms.

The University of Sheffield claimed in 2020 that "Gambling related harm should be seen as a public health issue and be recognised alongside harm from other forms of potentially addictive behaviour such as alcohol and smoking"


